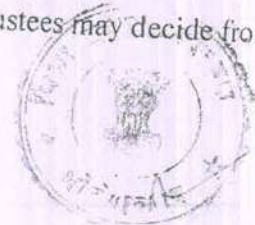

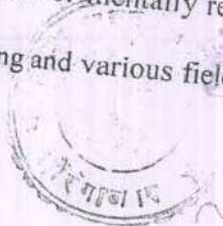

- (c) To borrow raise or secure payment of money and also the lend money either with or without security.
- (d) To sell dispose off, alienate or otherwise deal with any property comprising of the Trust Fund.
- (e) To let out, dispose off any immovable property comprised to the Trust fund for such period and a such rent on such terms and conditions as the Trustees in their discretion may think fit.
- (f) To open Account in the name of the Trust, trustees and /or Institution run and conducted by the Trust with a Bank or Banks, to Erate such account and give instruction to the Bank and to provide for the opening and operation of such account by one or more trustees or by an agent appoint by the Trustees.
- (g) To adjust, Settle, Compromise, Compound, refer to Arbitration, all actions, suits, claims and Demand, Proceeding regarding the Trust Fund.

- (j) To start, abolish, discontinue and restart any charity or charitable institution benefit of the general public and to impose any condition to any subscription or donation made by them.
- (k) To set apart and or allocate the whole or a part of the Income or the corpus of the Trust Fund or part therefore any of the objects of the Trust.
- (l) To join co-operation or amalgamate this Trust with other or others having kindred or allied objects, upon such terms and their discretion think fit particularly having regard to and in conformity with the objects and nature of this Trust.
- (m) To give any donation out of the Income or corpus of the Trust Fund or otherwise to different charitable Institutions, Societies, organization or Trust in India may hereafter be established for the like charitable purpose mentioned in these presents or any of them to enable such institution, Societies, Origination or Trustees to start maintain or carry out such Charitable object.

- (p) To establish, promote, manage, organise or maintain or to assist in establishing, promoting, managing, organising and maintaining by branch of the Trust of any other Trust or its branch with objects similar to those of this Trust and to promote or carry on the affiliations or amalgamation of such other Trust with this Trust.
- (q) To apply to the Government, Public bodies, Urban, Local Municipal District and other Bodies, Corporation, Companies of persons for and to accept grant of any aid, donation, gifts, subscription and other assistance with a view to promote the objects of the Trust and to discuss and negotiate with the Government Departments, Public and other Bodies, Corporations, Companies or persons, Scheme and other work and matters within the objects of the Trust and to put to any proper condition upon which such grants and other payments may be made.

(u) To transfer all the or any part of the property, assets, liabilities and engagement of this Trust to any one or more of the Trust, Societies, Institutions or Associations with which this Trust is authorized to Amalgamate.

(v) To Purchase or otherwise acquire and undertake all or any part of the property, assets, liabilities and engagement of any or more of the Trust, Societies, Institutions or Associations with which this Trust is authorised to Amalgamate and the Trustees shall be entitled to get lease of licence and pay the licence.

9. The Trustee shall be accountable only for such moneys and funds which will actually come to their hands.

10. The trustees will not be entitled to receive any remuneration, but the trustees may reimburse themselves all expenses actually incurred by them in connection with the Trust or their duties relating thereto and beneficiaries shall entitled of diversation of Income at source and may change the service.

11. The number of Trustees shall not be less than three and more than nine. If the number of the Trustees shall below two, the Trustees shall not except for the purpose of filling any vacancy, Act so long number is below the said minimum.

12. The Managing Trustee for the time being will be at liberty to appoint additional Trustees within the number mentioned above for such period or on

such terms as to retirement and re-appointment as the trustees for the time being consider proper.

13. A person shall cease to be a Trustee either.....

- (i) If he without leave of absence does not attend three consecutive meetings of the Trustees or for one calendar year, which is longer, or.
- (ii) If he is requested to resign by 3/4<sup>th</sup> or as near there to as possible of the remaining Trustees.

14. Every Trustee will; be at liberty to resign on giving one month's notice of his/her intention to do so.

15. The Trustees may from time to time frame rules for the conduct and regulations for the meeting of the Trustees in the absence of such regulations:-

- (a) Two Trustees shall form a quorum for a meeting of the Trustees.
- (b) All matters will be decided mutually by the Trustees.
- (c) Resolutions passed without any meeting of the Trustees but the circulation thereof and evidenced in writing under the hands of two-thirds of the Trustees shall be as valid and effectual as a resolution duly passed at a meeting of Trustees.

16. The Trustees shall have the power to determine in case of doubt whether any money or property shall or for the purpose of the charity be considered as capital or income and whether out of income or capital any expenses or outgoing ought to be paid or borne and every such determination shall be binding and conclusive provided that nothing contained shall be deemed to

18. The Trust and the Trust Funds shall be irrevocable for all times.

19. It is expressly declared that no part of the Trust property or its income for any accretion there to shall be applied for any purpose outside of India or for any purpose which is not a Charitable purpose in Law and all provisions here of shall be on strued according.

20. The office of the Trust shall be situated at Village- Chilki, P.O+PS- Amba, Aurangabad (Bihar)-824111 unless changed by the Trustees by two third majority.
